SHURA DELEGATIONS ELECTIONS 2015

Procedure for Conducting Elections

Read and used by presiding and assisting person(s) only

1. Read rules and guidelines for Sadr and Naib Sadr Saf Dom elections
2. Conduct the Sadr and Naib Sadr Saf Dom elections
3. Read the rules and guidelines for Shura delegates elections
4. Conduct Shura delegates elections
5. Regions should submit the hard copy of these results along with results entered in “Elections Tracker” spreadsheet to National Umumi department



Rules for Election for Sadr and Na'ib Sadr, Saf Dom

27. All the elections shall be open (e.g., by show of hands).

28. Any type of propaganda or canvassing implicit or explicit is not allowed in the election.

29. "The quorum for an election meeting shall be one half of the total members eligible to vote vide rule No. 22 of the Majlis concerned. If the quorum is short at the time of meeting and it has to be postponed, the quorum of next meeting shall be one third of the eligible voters of the Majlis concerned."

Eligible Voters are:

22 c. i. He should be regular Chanda paying member of Jamā'at and the Majlis Anṣārullāh.

ii. A Nāsir who is in arrears of Chanda Majlis Anṣārullāh for more than six month, and of Chanda Sālāna Ijtimā' for more than one year shall not be eligible to hold any office and shall not be allowed to participate or vote in the elections of Majlis Anṣārullāh.

iii. A Nāsir who is in arrears of Obligatory Chanda (viz Chanda 'Ām, Chanda Hiṣṣa Āmad for more than six months and Chanda Jalsa Sālāna for more than one year) shall not be eligible to hold any office and shall not be allowed to participate or vote in the elections of Majlis Anṣārullāh.

Guidelines for Election of Sadr and Na'ib Sadr, Saf Dom

Majlis Ansarullah Canada have received the approved list of names from Hazrat Khalifatul Mash the V (may Allah be his Helper!) for Sadr Majlis and Naib Sadr Saf Dom

- Presiding person **announces the names** of the candidates and all candidates will be **introduced** with their current offices if any in Jama'at and Majlis Ansarullah. Use the list provided to all majalis and regions ahead of time
- Members have **one (1) vote** for Sadr and one (1) vote for Naib Sadr Saf Dom and members should vote by raising their hand
- It is not necessary to vote for every nominee for Sadr and Naib Sadr Saf Dom. However every Nasir participating in elections must vote
- **Announce the votes** for each nominee. Majlis representatives for Majlis Shura, must vote in National Majlis Shura, for the nominees of Sadr Majlis and Naib Sadr Saf Dom who received the most votes in these elections
